

# THE CORPORATION OF THE COUNTY OF PRINCE EDWARD

## By-law No. 3025-2012

---

### A By-law to Provide for Fees and Charges and to consolidate certain By-laws related to Fees and Charges.

---

**WHEREAS** Section 391 of The Municipal Act, 2001, S.O. 2001, c.25 permits a municipality to pass by-laws imposing fees and charges for services and activities provided or done by or on behalf of it and for the use of its property;

**AND WHEREAS** The Council of the Corporation of the County of Prince Edward desires to impose some fees and charges for services and activities provided by the County, its officers or employees, or for the use of some or all of the County's properties;


**NOW THEREFORE**, the Council of the Corporation of the County of Prince Edward enacts as follows:

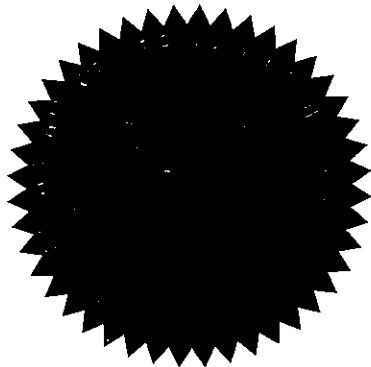
1. **THAT** the fees and charges set out in Schedules "A" to "R" attached to this By-law shall apply to every request made to the Corporation of the County of Prince Edward, and County Department or any officer or employee of the County, including but not limited to fees or charges for requests for documents, reports, letters and other information whether written, printed or electronically produced or stored or produced or stored in any other manner, searches, inspections, applications, permits, programs and the use of its facilities or properties, or for any other service or activity provided by the County to any person or any other authorized costs payable by the County;
2. **THAT** Schedules "A" to "R" shall be deemed to form a part of this By-law;
3. **THAT** all fees listed in the attached Schedules, where applicable, will be subject to the Harmonized Sales Tax (H.S.T.)
4. **THAT** fees and charges which are unpaid may be added to the tax roll of property owned by the persons responsible for paying the fees and charges and collected in the same manner as municipal taxes.
5. **THAT** should any provision of this By-law including any provision contained in one or more of the attached Schedules be determined by a court of competent jurisdiction to be invalid or void and of no force and effect, it is the stated intention of Council that such invalid provision shall be severable and the remainder of this By-law including any applicable Schedule shall continue in full force and effective;

6. **THAT** this By-law shall be deemed to constitute a part of the municipality's list for public inspection setting out which services and activities and which uses of its properties that are or will be subject to fees and charges, in accordance with section 392 of the Municipal Act, 2001, S.O. 2001, c.25
7. **THAT** By-law 2817-2011, being a by-law to provide for fees and charges and to consolidate certain by-laws related to fees and charges under the Municipal Act, as amended by By-law 2853-2011, 2900-2011 and 2959-2011 be and is hereby repealed;
8. **THAT** Section 15(1) of By-law No. 458-2000, being a by-law to provide for the erection of parking meters to control and regulate the parking of vehicles on certain streets within the municipality is hereby rescinded.
9. **THAT** the Schedule for Set Fines of By-law 1475-2005, being a by-law that regulates and controls parking on highways, in parking lots, on municipal property under the jurisdiction of the County, and on private property be rescinded.
10. **THAT** this By-law shall be known as the "Fees and Charges By-law;

6. Where possible, Public Works' fees will be obtained by the Planning Services Department staff when application is made and transferred internally.
7. Combined Applications Fee Reduction of \$200 for applications that can be processed concurrently with only one staff report and only one public meeting.
